LMYA's Lawsuit on Lake Pollution Spills is Settled

Tom Dogan, Commodore of the LMYA, has just gone to federal court and the judge has combined our suit with several others and issued a consent decree. Rather than try each suit separately, the combined consent decree resolves all of the issues that we raised on behalf of our plaintiffs. The steel mill which was responsible for dumping the dangerous pollutants into the Burns Waterway leading to Lake Michigan was Cleveland-Cliffs Inc. which bought the mill from ArcelorMittal USA. Under the consent decree. our individual plaintiffs will not be compensated for their losses because

there would have to be a massive amount of statements taken from expert witnesses, according to the judge.

The decree will, however, force the steel mill to deliver all of the environmental safeguards that we requested in our suit, namely, installing 24/7 monitoring for accidental spills for the next three years, immediate reporting of spills to all monitoring agencies, and a heavy 3 million dollar fine, (which goes to the federal government.) The waters of the lake will be safe once more from the effects of steel mill discharges.

As a result of this decree. Cleveland-Cliffs has decided to close down its coke battery in East Chicago which was the largest coke battery in the country. They will build somewhere else and convert from coal to natural gas which reduces their carbon footprint dramatically. They will then donate 127 acres of land near where the plant was located to Dunes National Park. It will be cleaned up by the Heinze Land Trust to turn it into park space. Also because of these suits being piled on, the other major steel

producer in the area, US Steel, has changed their plans to make a new coke battery on Lake Erie, and instead go to a natural gas fueled facility. Coke batteries leave a heavy carbon footprint and emit sulfuric acid into the air which poisons people and equipment, and potentially pollutes the waters in the process. Thus the suit which LMYA was the lead sponsor, has helped protect Lake Michigan and Lake Erie at the same time.

Milwaukee Breakwater Project—Protecting South Shore Yacht Club

SSYC Commodore Pete Engel reports that last month the engineering firm, Baird, has presented preliminary designs for the repairs of the Milwaukee breakwater to the County. The contract includes the breakwater at SSYC, (the north section,) and also the south section. The County will focus on the north section and move the design work on the south section to 2023. The 2023 budget requests will include the repair work to the north section and the engineering study for the south section.

Baird's deadline was April 30th to deliver the design and estimated costs to the County. The County is starting work on the permitting application with the various agencies that need to issue permits such as the DNR and the Army Corps of Engineers.

New Rear Commodores for Indiana and Michigan

Barb Lusco from Portage Indiana will be the new Rear Commodore for the Indiana Region. Barb is a member of Marquette Yacht Club and Izaak Walton. She is harbormaster at the City of Portage Sammie Maletta Public Marina and a member of the Portage Port Authority. She also serves on the Board of Indiana Dunes Tourism.

Alison Gaye Blind from Baroda Michigan has been named Rear Commodore for Michigan Region. She grew up on the lake, and has worked for the Michigan DNR in fisheries, a trout hatchery, US Coast Guard Auxiliary, Wolf's Marine, and Point Blue LLC. In the Coast Guard Auxiliary, she has been deployed three times for Hurricane Katrina, Caroli-

na floods, and the BP oil spill and some FE-MA disaster response teams. She received the National Coast Guard Auxiliarist of the Year honors in 2018 for work with youth boating safety outreach education, marine safety, and environmental protection. She currently serves as ADSO-MS-E as the assistant to the 9th

Western District Marine Safety Officer for the East side of Lake Michigan. She regularly patrols the waters near St. Joseph, South Haven, Saugatuck, and Holland Michigan. She is a member of the Great Lakes Yacht club and South Haven USCG AUX Flotilla. Welcome to both of our new rear commodores.
